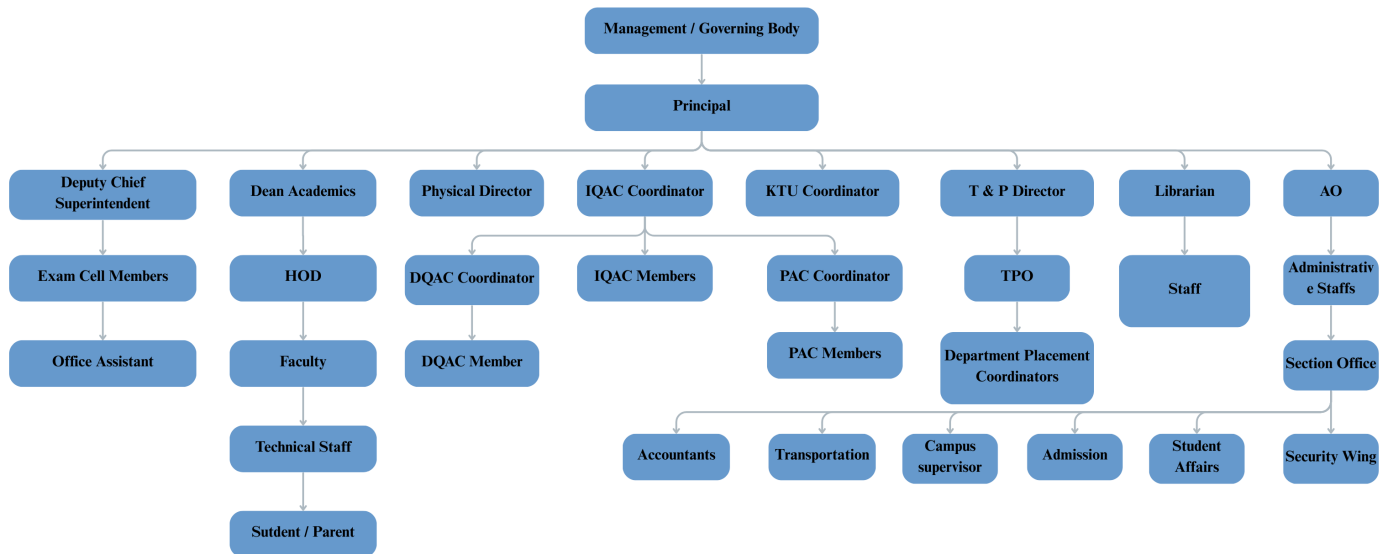

ADMISSION PROCEDURE

Undergraduate Programmes (UG): The admission into undergraduate engineering programmes (B.Tech) for all the branches of study are made as per the relevant Rules of Government of Kerala and statutory bodies such as APJ Abdul Kalam Technological University (KTU), AICTE.

- 50% of the total seats (Govt. Quota seats) are filled by (Commissioner of Entrance Exam – CEE through KEAM) and the remaining 50% seats constitute Management Quota. NRI seats are included in the 50% of the management quota seats will be filled by the management as per the relevant rules of the State Govt. and guidelines of the DTE issued from time to time.
- For Govt. Quota seats, candidates have to apply online mentioning the college code SNC and the branch of preference as and when announced by the Commissioner of the Entrance Examination.

CRITERIA OF ELIGIBILITY / PROCEDURE FOR ADMISSION

GOVERNMENT QUOTA

- Candidates must be citizens of India.
- Passed in Higher Secondary examination of the Board of HSE of Kerala or an examination recognized thereto.
- Candidates should qualify the Engineering Entrance Examination (KEAM) conducted by the Commissioner of Entrance Examination (CEE), Government of Kerala.
- 50 % of the total seats are filled by Commissioner of Entrance Exam – CEE.
- For Govt. Quota seats, candidates have to apply online mentioning the college code SNC and branch of preference as and when announced by the Commissioner of the Entrance Examination.
- Passed in Higher Secondary examination of the Board of HSE of Kerala or equivalent, with at least 45% marks in Mathematics, and 45% marks in Physics and Chemistry / equivalent subjects put together.
 - Candidates belonging to SC/ST/ SEBC or PD the minimum mark obtained in Physics, Mathematics, Chemistry/Computer Science/Biotechnology/Biology taken together in qualifying examination shall be 40% instead of 45%.
- AICTE TUITION FEE WAIVER SCHEME (TFW): 5% of the sanctioned seats in each branch (in addition to the sanctioned intake) will be filled by Government (based on KEAM rank and family income) as per the norms and eligibility laid down for the scheme.
- ECONOMICALLY WEAKER SECTION (EWS): 5% of the sanctioned seats in each branch (in addition to the sanctioned intake) will be filled by Government (based on

KEAM rank and EWS Certificate uploaded in CEE website) as per the norms and eligibility laid down for the scheme. Candidates have to select SNC and apply under EWS quota in CEE Portal.

MANAGEMENT QUOTA

- ❖ Candidates must be citizens of India.
- ❖ Passed in Higher Secondary examination of the Board of HSE of Kerala or equivalent, with at least 45% marks in Mathematics, and 45% marks in Physics and Chemistry / equivalent subjects put together.
- ❖ Candidates should qualify in the Engineering Entrance Examination (KEAM) conducted by the Commissioner of Entrance Examination (CEE), Government of Kerala.

Admission Procedure

- ❖ Subject to any orders that may be passed by the competent courts / authorities, admission will be only on the basis of merit determined by adding scores obtained in KEAM (for Mathematics, Physics, and Chemistry) conducted by CEE, and marks obtained for Mathematics, Physics, and Chemistry / equivalent subjects in the qualifying examination (board).

The score of KEAM and qualifying examination will be apportioned in the ratio 50:50.

NRI QUOTA

Criteria of eligibility for admission–50% marks separately in Mathematics and 50% Physics, Chemistry, and Mathematics put together.

Procedure: The College issues an advertisement after necessary approval. The spot admissions will be made according to the guidelines issued from time to time by the KTU. All admissions made at institute level are subject to approval of competent authorities.

LATERAL ENTRY SEATS

Students pass out from Polytechnic Colleges in Civil Engineering, Mechanical Engineering, Electrical and Electronics Engineering, Electronics and Communication Engineering and Computer Science Engineering can apply for Lateral Entry Seats. Applications forms for the lateral Entry seats are available from the college office.
